

## LINCOLN COUNTY HIGHWAY DEPARTMENT RULES FOR MOVEMENT OF OVERWEIGHT AND OVER-DIMENSION LOADS ON COUNTY ROADS

- 1. 10' wide or less no permit required.
- 2. Over 10' wide permit required.
- 3. Maximum length 96' 6"; rear escort vehicle is required.
- 4. Overweight/Over-Dimension Permit fee varies (see permit application).
- 5. Over-Dimension Permit fee is \$50 (single trip) or \$100 (annual). Examples of Annual Over-Dimension Permit eligible loads include: farm machinery, wind turbines, etc.
- 6. Minimum \$50,000 public liability & property damage insurance required.
- 7. Loads 16' wide or over requires escort vehicle (front and rear), acceptable to County Engineer. Applicant must notify both the Lincoln County Sheriff's office (507-694-1664) and the Lincoln County Highway Department (507-694-1464) prior to move and when move is complete.
- 8. Loads 20' wide or over requires flag persons at first public road intersection (ahead and behind, respectively), to direct and warn traffic.
- 9. Moves allowed in daylight hours only.
- 10. All axle loadings must be legal or posted weight or less.
- 11. No overweight loads permitted across restricted bridges/structures (see map) without verification by a registered engineer that the load will not damage the bridge/structure. The applicant pays for the engineering study.
- 12. Route to be driven by permit applicant prior to submitting application to ensure all clearance, width, and weight restrictions are satisfied.
- 13. Movement may be on any county road subject to restrictions listed above.
- 14. Applicant to show proposed route on copy of Lincoln County map.
