LINCOLN COUNTY BOARD OF COMMISSIONERS MEETING MINUTES

June 18, 2019 Courthouse Commissioner Room Ivanhoe, MN 56142

The meeting was called to order at 3:00 p.m. by Board Chair Mic VanDeVere, followed by the Pledge of Allegiance. Commissioners present were Joe Drietz, Rick Hamer, Corey Sik, Mic VanDeVere and Jack Vizecky. Also present was Lincoln County Auditor-Treasurer Deb Vierhuf. No conflicts of interest were noted.

Motion by Hamer, seconded by Sik to approve the consent agenda which included June 4, 2019 minutes and June 18, 2019 agenda. All voted in favor.

Amber Scholten, Emergency Management, informed the Board that she had been asked to represent the Southwest Regional Radio Board at the first ARMER Net Broadband State Conference held in Chicago, IL and asked for approval for out-of-state travel. Motion by Drietz, seconded by Sik to approve out-of-state travel for Amber Scholten to Chicago IL to attend the first ARMER Net Broadband State Conference and to represent the Southwest regional Board. All voted in favor.

Scholten informed the Board that the second safety training will be held on June 26th at 10:00 a.m. and 1:00 p.m. Anyone that was not able to attend the April training should attend this training. Information only.

Scholten informed the Board that Homeland Security and Emergency Management (HSEM) will be in Lyon County on June 26th at 1:00 p.m. If there are townships or cities looking for Federal Emergency Management Agency (FEMA) money, they should be at this meeting. Scholten will contact all the townships and cities in Lincoln County and inform them of the meeting. Information only.

Scholten informed the Board that the Hazard Mitigation Plan has been moving forward and it will be brought to the Board at a future date. Information only.

Scholten informed the Board that she is looking into what needs to be done with the radio tower at the Hole in the Mountain Park so it does not prevent us from getting grant dollars. Information only.

Joe Wilson, Lincoln County Engineer, presented project updates. They were as follows:

- Started on bridge safety inspections.
- Getting close to complete with paving plans.
- Surveys for 2020 projects.

Wilson presented plans for the Courthouse/Highway Parking Lot Improvement Project and requested approval to advertise. Wilson feels that if we do both parking lots at one time, it should save some dollars and if the bids come in too high, we can wait and rebid at a later date. Motion by Drietz, seconded by Sik to approve advertising for the Courthouse/Highway Parking Lot Project. All voted in favor.

Deb Vierhuf, Lincoln County Auditor-Treasurer asked for clarification on what account to charge the design and construction inspection for the Courthouse and Highway Parking Lot Improvement Project and informed the Board that we have an invoice for the May professional services from Wenck and that she would like this paid as an Auditor Warrant. Motion by Hamer, seconded by Drietz to pay Wenck for the design & Construction of the Courthouse/Highway Parking Lot Improvement Project out of the capital improvement account and to pay invoice No. 11903246 in the amount of \$6,160.59 as an Auditor Warrant. All voted in favor.

Wilson presented maintenance updates. They were as follows:

- Blading roads as weather permits.
- Culvert replacement work.
- Looked at the Dead Coon outlet. Area II and their engineers are also looking at the issue.
- Started hauling gravel for spot maintenance
- Bituminous patching will start soon
- Roadside mowing will start soon
- Originally we thought highway maintenance could upgrade the bridge that is load posted on County Road 1 but with the specs that are needed, we will be looking at hiring a contractor to do it.
- Looking to change supply companies for the Highway building

Wilson brought discussion to the Board regarding culverts & signs purchased through the County for Townships and Cities. Wilson was wondering if we should add a 10% handling fee for these items to cover the time it takes to order, bill, store, handle and load the materials. The Board would like to see us

work with the townships and cities on these type of things and were not in favor of charging a 10% handling fee. Information only.

Wilson informed the Board that Contract 04-2017 is complete and he would like to pass Resolution No. 32-2019 Final Payment of Contract 04-2017. Motion by Drietz, seconded by Hamer to approve Resolution No. 32-2019 Final Payment of Contract 04-2017 to Riley Bros. Construction Inc. in the amount of \$14,619.05. All voted in favor.

RESOLUTION NO. 31-2019 RESOLUTION OF THE LINCOLN COUNTY DITCH SYSTEM FOR ONE-YEAR LOAN

BE IT RESOLVED by the Board of Commissioners, acting Ditch Authority, County of Lincoln, State of Minnesota, that the following ditch transfers are herewith adopted; and

BE IT FURTHER RESOLVED that the Lincoln County General Fund loan to the following ditch system in the total sum of \$128,776.29 for the duration of one (1) year with interest at the rate of 4%.

The following individual ditch system will have a deficit cash balance. Minn. Stat. 103E.655, subd. 2 allows for loans to be made from the General Fund to a ditch system with insufficient cash to pay

expenditures. If the County Board transfers money from another fund to a drainage system account, the money must be reimbursed from the proceeds of the drainage system account that received the transfer.

Fund Amount 40-784 Judicial Ditch 19 – Redetermination Fund 128,776.29

Consider the approval of the transferring monies in the amount of \$128,776.29 as of June 18, 2019 from the General Fund to individual ditch system with deficit cash balances.
