LINCOLN COUNTY BOARD OF COMMISSIONERS MEETING MINUTES

October 15, 2019 Courthouse Commissioner Room Ivanhoe, MN 56142

The meeting was called to order at 9:00 a.m. by Board Chair Mic VanDeVere, followed by the Pledge of Allegiance. Commissioners present were Joe Drietz, Rick Hamer, Mic VanDeVere and Jack Vizecky. Commissioner Sik was absent. Also present was Lincoln County Auditor-Treasurer Deb Vierhuf. Glen Petersen, Lincoln County Attorney, arrived at 9:30 a.m. No conflicts of interest were noted.

Motion by Drietz, seconded by Vizecky to approve the consent agenda which included October 1, 2019 minutes, October 15, 2019 agenda and the FY2020 Snowmobile Maintenance Grant Agreement. All (4) voted in favor.

Robert Olsen, Environmental, asked for approval of an amended Southwest Regional Development Commission contract. The cost estimate to do the Ordinance work increased from \$12,800.00 to \$15,000.00 Motion by Drietz, seconded by Hamer to approve the Southwest Regional Development Commissioner (SRDC) Contract Amendment. All (4) voted in favor.

Olsen gave an update on the following items:

- Easements are still being worked on at the Hendricks rural dumpster site.
- Due to a ditch issue on JD #31, about 600 feet of tile needed to be replaced.
- One of the current Environmental pickups is in need of \$3,500.00 in repairs. The State bid for a similar pickup is \$26,000. Olsen has \$30,000 budgeted and asked the Board to consider replacing the current pickup with a 2019 F 150. Olsen will bring this back to a future meeting.

At 9:30 a.m. sealed bids were opened for the lease of approximately 18 acres of hay land at the Lincoln Landfill Site located in section 4 of Ash Lake Township for a period of three years. The bids received were:

- Jay Blegen \$536.00 per year
- Ryder Olsen \$1,000.00 per year
- Dusty Linneman \$508.00 per year

Motion by VanDeVere, seconded by Drietz to accept highest bid from Ryder Olsen for \$1,000.00 per year for the period of December 1, 2019 through November 30, 2022 for approximately 18 acres of hay land in Ash Lake Township. Commissioner Drietz, Hamer and VanDeVere voted in favor. Commissioner Vizecky abstained. Motion carried by majority vote.

Joe Wilson, Lincoln County Engineer, presented project updates. They were as follows:

- R & G is part way though the gravel surfacing project on County Highway 10. The
 project deadline is October 18th. R & G may not finish by this date and Wilson will
 look at if we should fine them for not getting the project complete.
- Duininck has finished the patching project. There were a couple spots they were unable to patch due to mud on the road. There may be an extra cost to have them come finish those areas.
- Continuing to work on 2020-2021 survey and plan work.
- We may need to do a hydraulic study on a couple more culverts. The Board was in consensus with doing the hydraulic studies if needed.

Wilson presented maintenance updates. They were as follows:

- Fall mowing is about ½ complete.
- Repairing soft spots on County Roads 101, 103 and 118.
- Gravel hauling and surfacing is probably done for the year. 25 miles did not get done due to the weather.
- Will be doing tree and brush cutting yet this fall.
- Looked into storage options at the Lincoln County Fairgrounds. The openings in the buildings are too small to store what we need.
- The City of Lake Benton is looking at applying for State Park Road Funds to pave between US Highway 75 and the parking lot by the boat landing. This is a DNR funded project. This will be a 2020 project with applications due by the end of October, 2019. The Lincoln County Highway Department will need to administer the project.

Wilson is still reviewing the Blazing Star 2 Development Agreement. This will be finalized soon. Information only.

Megan DeSchepper, MnDOT, reviewed the 10 year road project plan. The following projects are planned in Lincoln County:

- 2023 Replace bridges over Yellow Medicine River West of US 75, near Ivanhoe.
- 2023 Reclaim and overlay on MN 271 from MN 19 to Railroad Street in Hendricks and thin mill and overlay on MN 271 from Maple Street in Hendricks to the State line.
- 2025 US 14 Replace bridge over a stream crossing 1.8 miles E of the South Dakota/Minnesota state line
- 2025 US 75 Replace bridge 1.6 miles S of the Lincoln/Yellow Medicine County line over a stream
- 2026 US 75 Cold in place recycle from Pipestone Creek in Pipestone to S Valley Street in Lake Benton.
- 2027 US 14 Cold in place recycle plus ADA in Tyler from Jesse St in Lake Benton to just E of the Lincoln/Lyon Co line.
- 2027 US 14/75 Downtown reconstruction in Lake Benton.
- 2029 MN 19 Reclaim and overlay from Ivanhoe to CSAH 5 with a medium mill and overlay in Ivanhoe.
